



2026 Excavation Services Tender

The South Saskatchewan River Irrigation District No. 1 Inc. (SSRID) invites tenders for excavation services to clean up to 50 km of Irrigation District Drain Ditch Infrastructure in the Outlook, Saskatchewan area.

Tenders must be clearly marked **“2026 Excavation Services Tender”** and submitted to the SSRID District Office by mail, email, or in person no later than **4:00 p.m. CST on Friday, March 13 2026.**

Scope of Work

- Excavation and cleaning up to 50 kms of Irrigation District drain ditch infrastructure to remove accumulated debris and fill material through trenching or similar methods.
- Spoil piles resulting from the excavation shall remain in place adjacent to the ditch.
- Work locations will be determined by the SSRID Operations Manager.
- The work shall commence on or after **May 1, 2026**, subject to the start of the spring thaw. Once commenced, the work must proceed continuously (weather permitting) until completion.
- Pre- and post-excavation surveying is required to document ditch profiles and elevations. The Contractor shall provide survey data in a format acceptable to SSRID.
- SSRID will provide hard-copy mapping resources and conduct a site tour of the locations for qualified bidders upon request.

Contractor Requirements

- The Contractor shall supply all necessary equipment, labour, supervision, materials, and other resources required to complete the work in accordance with the specifications.
- The Contractor shall follow directions from the SSRID Operations Manager regarding work sequencing, locations, and any adjustments to the scope.
- Equipment must suit the requirements of the job and must be equipped with GPS grade control capabilities.
- All operators and personnel must be trained, competent, and compliant with relevant Occupational Health and Safety Regulations of Saskatchewan.



Tender Submission Requirements

Tenders must include the following:

- Contractor's full legal name, business address, contact person, phone, and email.
- Pricing: Bids accepted on a per-hour basis, with preference given to bids providing a per-kilometer unit price. The unit price(s) must include all equipment, labour, supervision, surveying, and all other costs necessary to complete the work.
- Proof of minimum \$2,000,000 liability insurance (certificate of insurance).
- Saskatchewan Workers' Compensation Board registration number and a current letter of good standing.
- Detailed list of equipment available for the project, including make, model, year, and confirmation of GPS capabilities and biodegradable fluids.
- References would be advantageous.

Selection Criteria

- SSRID reserves the right to accept or reject any or all tenders, in whole or in part, without explanation.
- The lowest tender, or any tender, is not necessarily accepted.
- Selection may consider factors beyond price, including (but not limited to) contractor experience, equipment suitability, references, proposed schedule, environmental compliance, and overall capability to perform the work safely and efficiently.
- Tenders must be complete, clear, legible, and compliant with all requirements. Incomplete tenders may be rejected.
- A tender may be withdrawn without prejudice by written or in-person notice to SSRID before the closing date and time (4:00 p.m. on March 13, 2026).
